OUTLOOK NEBRASKA EMPLOYS PEOPLE WHO ARE VISUALLY IMPAIRED THROUGHOUT THE ORGANIZATION; ABOUT 60% OF OUR ASSOCIATES HAVE IMPAIRED VISION AND WE ARE THE LARGEST EMPLOYER OF THE BLIND IN NEBRASKA.
